



Dear LH-Coin token holders!

Please be reminded that according to 2017-2018 token sale rules, all token holders will have the risk of low market value compensated to them. The compensation procedure is similar to standard bonus procedures of LH-Crypto broker. We will give thorough instructions on the details of this process later.

First, let's define the **Market risk**:

Market risk – market risk is the possibility of an investor experiencing losses due to factors that affect the overall performance of the financial markets in which he or she is involved. LH-Crypto promised to cover these risks. At first, the price of the token (during the Pre ICO stage) was equal to 0,1 USD. At the moment of this announcement is being written, the official price of the token at Yobit exchange is equal to 0,0018 USD. Therefore, the compensation equals to 0,0982 USD per token.

Now let's turn to the **compensation accrual procedure**:

It will run in two stages:

- 1) *Creating and verifying accounts for compensation accrual;*
- 2) *Compensation accrual.*


1) Creating and verifying accounts:

This stage will last for one more month, till March 1, 2021. At this stage, all the token holders who would like to receive the compensation will have their accounts created and verified; also, the project will check if the holders bought the tokens during the ICO and are therefore eligible for the compensation programme.

During February 2021, you need to **create a trading account** at lh-crypto.com. When choosing the type of the account, please pick the Standard service account:



2) Compensation accrual:

During March 2021, we will check all the accounts created at Stage 1 and will accrue the compensation. All the necessary instructions for such accounts will be published later. Also, all token holders with over 1000 USD on their accounts will be able to use the services of a personal online consultant for free.

Attention! If the Compliance Department reveals a forgery or other misuse, the account will be blocked immediately and the company will not provide the compensation or any other service.
