NECESSARY REQUIREMENTS:

- Translators without portfolios are not considered;
 - Automatic translators are not allowed;
 - After creating groups, the translator is responsible for groups moderation;
 - Links to ready groups are published here;
 - Reward: 3 USD for 1000 symbols of translated text (blank spaces are not counted);
 - Priority languages: Spanish, German, Korean, Japanese, Chinese, Italian. Other languages are also welcomed.

The project team evaluates the quality of the content and the audience, the final decision non-negotiable.

Priority content: program reviews, promotional campaign overview, reposts of participants' news.



NECESSARY REQUIREMENTS:

- Content with fake views/likes will be disqualified;
 - Any content must be publicly available;
 - Publications must be unique; min. 2000 symbols in size (blank spaces are not counted);
 - The minimum video duration is 2 m. 30 sec.;
 - Created content should be thematically related to the project;
 - The articles/videos descriptions must contain a link to the [project's website](#);
 - The team reserves the right to refuse any participant without explanation;
 - The reward ranges from 1 USD to 25 USD depending on the quality of the content.

GENERAL **GIIS** 'BOUNTY CAMPAIGN' TERMS

- Register on the [GIIS website](#);
- In the 'Choose a token' field, select 'Bounty';
- Confirm the registration via the email and add the 'Current account' number (shown on the picture below) to the Google table. It is to your personal LH-Crypto account that you will receive rewards to;

- Publish reports weekly;
- Reports are reviewed weekly. Rewards are transferred on the monthly basis, between the 1st and 10th date of the *next* month;
- *One* participant is allowed to open *one* account. Using multiple accounts is prohibited and will result in disqualification;
- Any content must be of good quality and relevant to the project;
- The decisions of the project team are final and not negotiable;
- The project team is eligible for changes of the campaign rules;
- The project team reserves the right to exclude any participant without any explanations.
